#### **PRICE PROTECTION**

#### **VEHICLE EXCISE DUTY**

The amount of Vehicle Excise Duty (road fund licence) payable on new cars varies depending on the level of carbon dioxide ( $CO_2$ ) emissions produced by the vehicle.  $CO_2$  emissions are measured in grammes (g) per kilometre (km) travelled and divided into 13 charging bands shown in the table below.

From 1 April 2010 the Government introduced a new 'first year rate' of Vehicle Excise Duty payable on all new cars. In subsequent years the amount of Vehicle Excise Duty payable will revert to the standard rate
